ACCIDENT & INCIDENT REPORTING

1 INTRODUCTION

- 1.1 By following this accident reporting and investigation procedure, QASF Company Ltd can effectively identify and address the causes of accidents, prevent future incidents and ultimately enhance workplace safety.
- 1.2 Reportable incidents should be recorded as close to the time of the incident as possible.
- 1.3 As much information should be recorded in order to achieve suitable corrective actions.
- 1.4 Photo and video evidence shall be recorded as necessary.

3 PROCEDURE

- 3.1 Secure the Accident Scene and Provide Immediate Care
 - 3.1.1 Ensure the safety of all employees and provide necessary medical attention to any injured persons.
 - 3.1.2 Isolate and secure the accident site to prevent further injuries or damage and preserve evidence for investigation.
- 3.2 Notify Relevant Parties
 - 3.2.1 Immediately inform supervisors, safety officers, and management about the accident.

3.1 Investigation

- 3.1.1 Interview the injured employee(s) and/or witnesses as soon as possible to obtain their accounts of the incident.
- 3.1.2 Collect physical evidence, take video/photographs, and document the accident scene thoroughly.
- 3.1.3 Review relevant documentation, safety protocols, training records, equipment maintenance logs, and previous incident reports.

3.2 Analyze the Facts

- 3.2.1 Determine the sequence of events leading up to the accident, identifying any unsafe conditions, behaviors or actions that may have contributed.
- 3.2.2 Conduct a root cause analysis to uncover underlying systemic issues, such as inadequate safety programs, policies, or procedures.

3.3 Develop Corrective Actions

- 3.3.1 Based on the investigation findings, identify corrective actions to prevent similar incidents from occurring in the future.
- 3.3.2 Corrective actions should be specific, constructive, and address the root causes identified in the investigation.
- 3.4 Prepare an Accident Investigation Report (See Section 4)
 - 3.4.1 Document the findings, including a detailed description of the accident, the sequence of events, contributing factors, and recommended corrective actions.
 - 3.4.2 Include supporting evidence, such as photographs, diagrams, and witness statements.

3.5 Implement and Monitor Corrective Actions

- 3.5.1 Assign responsibilities and set deadlines for implementing the corrective actions.
- 3.5.2 Regularly monitor and evaluate the effectiveness of the implemented measures, making adjustments as needed.

3.6 Communicate and Train

- 3.6.1 Share the investigation findings and corrective actions with all relevant parties, including employees, supervisors, and management.
- 3.6.2 Provide training to employees on any new safety procedures or equipment resulting from the investigation.

3.7 Continuously Improve Safety

- 3.7.1 Regularly review and update safety policies and procedures based on the lessons learned from accident investigations and industry best practices.
- 3.7.2 Foster a strong safety culture by encouraging employee involvement, providing ongoing training, and recognizing safe work practices.
